ABOUT the Student Support Fund:

The Student Support Fund (SSF) was initiated in April, 2017, it is designed to provide financial and other support to present students who may find themselves in exceptionally difficult circumstances which may require immediate short-term aid during their course of study. No such fund has ever existed in The University before and the Vice Chancellor considers it important to ensure that funds are targeted at ensuring that challenged students can also succeed.

What is the Student Support Fund?

The Student Support Fund (SSF) is provided by the University to help students who have genuine and unavoidable short term financial or personal difficulties which place them in danger of not completing because of these struggles despite having received all other financial and other support available to them.

Who Can Apply: Any student enrolled in the University of Guyana and attending classes who demonstrates with evidence their challenging circumstances and inability to garner support from any other avenues. The nexus must be made between these circumstances and the impact on the student's ability to complete their academic programme.

Who will Qualify for Support: Since applications are means-tested and the fund is currently small, not all applications will be successful. However, the SSF aims to support as many students as possible who are deserving.

What Kinds of Support Is Available:

Loans – sums up to 100,000 Guyana dollars to defray hardship costs. Repayable with no

interest but before graduation.

Grants – up to G\$50,000 to defray immediate hardship costs. Non –refundable.

Employment Opportunities and Assistantships: These may be continuous, short term and occasional paid

projects and or assignments which can be made available to students who indicate that they need

supplemental income but who are not in extreme or dire circumstances. They however may have been in

such circumstances and may need this kind of support to help keep them viable.

Who administers the fund: This fund will be administered through the Registry possibly

the Office of Student's Welfare in The Registry, or designate of the Registrar, but shall be chaired at all

times by the accounting office for the fund which is PACE.

Disbursement is by application and a committee comprising representatives from the following

constituencies will decide on recipients upon considering each written submission, investigation and case

presented.: PACE, Registry, Vice Chancellor's designate, Student Union, Berbice Representative, Assistant

Dean, elected by the Academic Board, private sector representatives/large donor. The Committee may

meet/virtually or via email round robin as directed by its Secretary or Chair since it is anticipated that many

of the cases presented will be urgent and therefore time sensitive which requires a speedy turn around.

Transparency and Accountability:

PACE will indicate how much has been raised on a quarterly basis. PACE will also on a quarterly basis

publishes as well as send the disbursements made to students to donors along with letters of thanks from

students who have received from the fund. However, as soon as disbursements are made PACE's website

will be updated with details in a manner which is discreet about students' personal information and

circumstances and in keeping with the ethic of protecting their identities from the public and minimizing

harm.
